In keeping with the spirit of Muncie, Indiana’s official motto, “Imagine the Possibilities When We Work Together,” the Muncie City Council just passed the strongest companion animal protection law in the nation, demonstrating that when it comes to caring for the community’s neediest dogs, cats, and other shelter animals, the city’s commitment to the will of its people is more than mere words. Not only has municipal shelter leadership in Muncie overhauled its operating procedures to protect animals and better reflect the community’s values, but it has empowered the animal-loving citizens of Muncie as collaborative partners in caregiving, transforming the city into one of the safest communities for shelter animals in the nation. Just as exciting, the city leadership of Muncie demonstrated its commitment to ensuring that those changes and the success they foster endure, giving them both permanence and continuity through the strength of law. As such, Muncie now stands as a model of both compassionate care and how to sustain it for communities across America.

What is to credit for Muncie’s success? Below is a side-by-side comparison of the sheltering policies and practices that Muncie has enshrined into legislation, protocols which have allowed its municipally funded, open-admission animal control shelter to stand in stark contrast to the majority of American shelters whose practises continue to result in the needless deaths of millions of dogs and cats nationwide every year. If every shelter in the United States adopted the same innovative and compassionate approach to sheltering now mandated by Muncie law, animals who now leave our nation’s shelters out the back door in garbage bags would leave out the front door in the loving arms of families. Just like they do in Muncie.


